Who can register?

Any person who has the right to register on behalf of a legal person. *For example, a biomedical hospital engineer who has been empowered to sell equipment as part of his or her responsibilities can register as a Seller.*


1. Prepare the following information about your company : Company Registration and VAT Number, and if your organization is subject or not to VAT.



REGISTRATION PROOF: Extract from the Company Register issued within the last three months, in the case of an organization or soletrader, this can be a proof of registration from the official authority

IDENTITY PROOF: ID or Passport of the Legal Representative and Bank Account ID of the Company

ARTICLE OF ASSOCIATION: Certified articles of association (Statute)

SHAREHOLDER DECLARATION: Declaration of individuals or legal entities which own directly or indirectly 10% or more of the shared capital of the company. The document “Beneficial Ownership Statement” is available for upload during registration.

You are able to complete your registration and upload the documents later on.
